

1. CONSOLIDATION

ALL ORDERS TO SAME ADDRESS SHALL BE CONSOLIDATED INTO ONE SHIPMENT PER DAY. FOR LESS THAN TRUCK LOAD (LTL) THIS MEANS ONE BILL OF LADING. FOR SMALL PARCEL SHIPMENTS THIS MEANS ONE MASTER AWB LABEL. EXCESS TRANSPORTATION COSTS TO GE AEROSPACE RESULTING FROM FAILURE TO FOLLOW THE PRESCRIBED ROUTING WILL BE DEBITED TO THE SELLER. FOR MORE DETAILS ON HOW TO CONSOLIDATE MATERIAL, REFER TO REMARK E12.

2. PRE-ALERTS

PRE-ALERTS ARE EMAILS CONTAINING SHIPMENT DETAILS SENT TO BROKERS AT THE TIME OF SHIPMENT TO FACILITATE INTERNATIONAL BORDER CROSSINGS. PRE-ALERTS MUST BE SENT IN ALIGNMENT WITH REQUIREMENTS SET FORTH WITHIN THE APPENDIX. **SEE APPENDIX A** FOR EMAIL TEMPLATE OF PRE-ALERTS AND CONTACTS.

FAILURE TO SEND PRE-ALERTS WITHIN 24 HOURS OF BEING TENDERED TO THE CARRIER AND SENT TO THE CORRECT PARTIES WILL LIKELY RESULT IN DELIVERY DELAYS. IF A PRE-ALERT IS NOT SENT BY A SELLER OR SELLERS CARRIER IN ALIGNMENT WITH THE APPENDIX AND DELAYS ARE CHARGED TO GE AEROSPACE, GE AEROSPACE MAY ISSUE A DEBIT MEMO FOR THE CHARGES TO THE SELLER.

3. ROUTING

ROUTING MATERIAL WHERE TRANSPORTATION IS NOT PAID BY GE AEROSPACE SELLER TO SELECT THE CARRIER OF THEIR CHOICE THAT WILL PROVIDE SAFE TRANSIT AND MEET GE AEROSPACE DELIVERY EXPECTATIONS.

ROUTING MATERIAL WHERE TRANSPORTATION IS PAID BY GE AEROSPACE AT NO TIME SHALL SELLER LEVERAGE THEIR CARRIER FOR GE AEROSPACE PAID TRANSPORTATION. COSTS FROM SELLER'S CARRIER ARE THE RESPONSIBILITY OF THE SELLER AND WILL BE REFUSED OR DEBITED TO SELLER.

A. SELLERS USING SUPPLYLINE/DEMANDLINE

THE ROUTING PROVIDED BY SUPPLYLINE WHEN USING "ALLOW SUPPLYLINE TO CREATE" & "DO NOT CREATE YET; ASN WILL GO ON UNIT LOAD" OPTIONS WILL RESULT IN A SHIPMENT PAID BY GE AEROSPACE USING THE APPROPRIATE CARRIER, MODE AND SERVICE LEVEL AND ENSURING THE CARRIER HAS THE PROPER DETAILS TO BILL GE AEROSPACE. THE SUPPLYLINE/DEMANDLINE TRANSPORTATION LABELS MUST BE LEVERAGED TO FACILITATE TRANSPORTATION AND CANNOT BE REPLACED WITH DIFFERENT LABELS.

LEVERAGING SELLERS OWN ROUTING, "I HAVE ALREADY CREATED", SHALL ONLY BE LEVERAGED IF

- THE SELLER IS PAYING FOR THE TRANSPORTATION
OR
- IF SUPPLYLINETRANSPORTATIONQUESTIONS@GEAEROSPACE.COM OR SUPPLYLINEROUTING@GEAEROSPACE.COM HAS AUTHORIZED THE USE OF THIS OPTION
OR
- THE SHIPMENT HAS A DROP SHIP DOCK CODE (DEFINED BELOW)

DROP SHIPMENTS, DEFINED AS DOCK CODES DS OR ANY ENDING IN X EXCEPT FOR ZX, SHALL INPUT CARRIER AS OTHER, TRACKING AS "TBD" AND CREATE THE ASN USING "I HAVE ALREADY CREATED". THEN EMAIL SUPPLYLINEROUTING@GEAEROSPACE.COM THE DETAILS IN **APPENDIX B** AND IF INTERNATIONAL, THE COMMERCIAL INVOICE. SUPPLYLINEROUTING@GEAEROSPACE.COM WILL PROVIDE THE CARRIER PAPERWORK AND TRACKING NUMBER. SUPPLIER MUST UPDATE THE TRACKING NUMBER OF "TBD" IN SUPPLYLINE/DEMANDLINE WITH THE TRACKING NUMBER PROVIDED. FURTHER HELP ON DROP SHIPMENTS CAN BE FOUND ON SCORE WEBSITE UNDER SUPPLYLINE TRAINING.

ANY EXPEDITE REQUESTS MUST HAVE A SUPPORT CENTRAL PREMIUM TRANSPORTATION AUTHORIZATION (PTA) COMPLETED BY GE AEROSPACE SOURCING. SELLER MUST INPUT PTA INTO SUPPLYLINE IN THE "GE PROVIDED ME A PTA CODE" FIELD OR SUPPLYLINEROUTING@GEAEROSPACE.COM WILL PROVIDE ALTERNATIVE INSTRUCTION.
